The Stewards, having received a report from the official FIA EHC Technical Delegate (Annex 3 to the Initial Scrutineering Report), having examined the documents, heard the driver Giancarlo Maroni Junior, have considered the following matter, determine the following:

Driver and car No: Giancarlo MARONI Junior, #29

Competitor: Giancarlo MARONI Junior

Time: Initial Scrutineering

Fact: During the Initial Scrutineering FIA TD found that the survival cell does not meet the safety requirements as the Article 259-16.2 of the Annex J to the ISC for sport production cars prescribes. The safety structures E2-SC cars built as from 01.01.2004. must comply with the prescriptions of the Art. 259-16.2 of Appendix J.

Offence: Breach of Article 259-16.2 of the Appendix J to the ISC




Decision: The Stewards decided:

1. Approve Car #29 to start in round N° 9 of the FIA EHC 2022
2. To inform the FIA Hill Climb Commission Secretariat that this car must be adapted to the approved chassis as it is mentioned in FIA TD report, "Appendix 3".
3. To inform the Panel of the Stewards for the next event of the EHC that this car must be adapted to the approved chassis.


Reason:
